Payment Terms: Full payment is due with your registration form for all markets. If you would like to pay by check, please make checks payable to Fast Forward and mail to: 1399 N. Cuyamaca Street, El Cajon CA 92020. Your registration is not confirmed until your payment has been received.

Cancellations: All cancellations must be submitted in writing no later than 60 days before the event to receive a full refund, minus a \$45 handling fee. There will be no refunds for cancellations made within 60 days of the event.

Insurance: Exhibitor and exhibitor display contractor(s) shall maintain Comprehensive General Liability Insurance and Personal Injury coverage for all Exhibitor's activities at the event, all at Exhibitor's sole cost and expense. Policy limits shall be at least \$1,000,000/\$1,000,000 Bodily Injury and Property Damage combined. Exhibitor and exhibitor display contractor(s) shall also maintain, at their sole cost and expense, Workers Compensation Insurance for employees participating in the event.
